Dear Chairwoman Clarke & Members of the Congressional Black Caucus,

As the Commissioners of the Central Intercollegiate Athletic Association (CIAA), Mid-Eastern Athletic Conference (MEAC), Southern Intercollegiate Athletic Conference (SIAC), and Southwestern Athletic Conference (SWAC), we are writing to express our collective support for Student Compensation and Opportunity through Rights and Endorsements (SCORE) Act and urge for its bipartisan support and passage.

As you know, the CIAA, MEAC, SIAC, and SWAC represent Historically Black Colleges & Universities (HBCUs) within Divisions I and II of the National Collegiate Athletic Association (NCAA). As members of the NCAA, our four Conferences include 48 institutions (see appendix for full list) spanning nearly twenty states. We serve 15,000 student athletes, and bring together millions of HBCU alumni, fans, and communities in celebration of our rich history and traditions.

Prior to the SCORE Act's jurisdictional committee consideration in the House of Representatives, we spent the past few years meeting with a broad spectrum of Congressional Black Caucus (CBC) Members and their staffs to provide education on our core issues and share the HBCU sports communities' urgent need for federal legislation that can adequately address the challenges we are facing in our respective athletic conferences. While that initial engagement was critical for establishing a productive dialogue about how Congress can find consensus on comprehensive solutions, the SCORE Act now provides Members an active opportunity to tangibly support athletics at HBCUs at this pivotal juncture.

Despite a range of historic recent changes in collegiate sports designed to support student-athletes, opportunities for predominantly Black students at our institutions are still at risk. Potential regulatory decisions and excessively egregious litigation threaten to change the face of college sports should the status quo environment go unaddressed. Specifically, there continues to be a growing patchwork of state laws impacting college sports and creating disparities and confusion among our prospective and current student-athletes. The various state laws and onslaught of court cases have made it difficult for conferences like ours to continue to provide developmental and competitive opportunities for member institutions and student-athletes. Retention is also a challenge within our HBCU student athlete population due to increasing differences in state laws and legal activity that have all but eliminated a level playing field.

As the landscape of collegiate athletics continues to evolve, now is the time to act and establish a national framework of core principles and practices that can help standardize the intercollegiate

experience for institutions and student athletes alike. As such, we believe the SCORE Act effectively addresses our following top priorities:

- 1. The SCORE Act protects future opportunities for student-athletes by ensuring they are not employees of their institutions. Like the majority of our mid-major and Division II peers, most HBCUs do not generate significant revenue and rely heavily on school appropriated funds and donations. Classifying student-athletes as employees would pose an existential threat to the sustainability of our athletic programs and schools, and in some cases could lead to the elimination of intercollegiate athletics.
- 2. The SCORE Act provides limited liability protections for associations and conferences like ours to make and enforce reasonable uniform rules
- 3. The SCORE Act preempts the current patchwork of state laws to create a nationwide clear set of shared rules.

In closing, as we all work collectively to drive better outcomes for student athletes at HBCUs and better outcomes for the broader HBCU community we urge Members of the CBC to consider cosponsoring this bill and supporting its passage on the House floor.
