Dear Speaker Johnson and Democratic Leader Jeffries:

On behalf of the National Retail Federation (NRF), I write to express our strong support for the "One Big Beautiful Bill." This legislation provides meaningful tax relief to working families — the backbone of the American consumer economy. By helping these families keep more of what they earn, the legislation will strengthen household budgets and drive demand across Main Street businesses. The bill aligns with key elements of NRF's priorities for pro-growth tax policy, by:

- Providing meaningful tax relief to working families, strengthening household budgets and fueling demand.
- Restoring pro-growth provisions, such as full expensing for investments and R&D incentives, to spur innovation and job growth.
- Enhancing tax policy clarity, offering businesses certainty in planning for the future.
- Balancing benefits to workers and job creators while promoting sustainable growth.

The retail industry believes that a strong economy starts with policies that empower consumers, support business investment and promote competitiveness. This package delivers on those goals and will help keep America's economic engine running strong — all while helping retailers continue to create jobs and invest in communities across the country. We urge members of the House of Representatives to vote for this bill to provide for reconciliation of H. Con. Res 14, the "One Big Beautiful Bill."
