Dear Distinguished Congressional Representatives:

As leaders of the Rocky Mountain Athletic Conference's Student-Athlete Advisory Committees (SAAC) at our 15 member institutions, and on behalf of nearly 6,000 student-athletes in the RMAC, we are reaching out to request your support for the Student Compensation and Opportunity through Rights and Endorsements Act (SCORE Act), as a critical step in protecting student-athletes' rights, opportunities, and well-being.

RMAC SAAC representatives support this legislation because it protects women's sports and Olympic sports, standardizes national NIL activity, provides protections against predatory NIL agents, and forces greater financial transparency around the funding of collegiate athletics. The SCORE Act also supports our education and degree completion by encouraging increased access to academic and career counseling for student-athletes, providing robust mental health services and education, and improving post-enrollment benefits for injured student-athletes.

Above all, we recognize the threat of classifying student-athletes as employees of their schools and consider the SCORE Act to be the next step in preserving the NCAA student-athlete experience, specifically at the Division II level.

"My time at UCCS has been filled with some unbelievable experiences – experiences that would not have happened if my focus was aimed at financial gain. Being a student-athlete highlights the concept of amateurism, which preserves the student-athlete focus on education, personal growth, and a love for the game. I believe that this time of our lives should be used as a pathway, rather than a stepping stone, to help us reach our ultimate career goals and dreams. Maintaining amateur status for student-athletes encourages us to balance academics with athletics and ultimately prepares us for our future, both on and off the field.

Specifically, on our campus, classifying athletes as full-time employees would destroy campus life. There are numerous scenarios where student-athletes engage with other students on campus and make them feel a part of something special. Taking this away would lead to a divide between athletes and the general student body, threatening the opportunity to represent our schools and everyone a part of it."

"Division II athletics have made a significant impact on my life. The ability to continue my athletic and academic career, as well as make a positive impact on my community, has been something for which I am deeply grateful. I have been able to maintain balance and stability in my life because of the activities I've been involved in – most importantly, being a student first.

Under the employee model, I would become a dispensable athlete and would not have been recruited or hired by any college. Most Division II schools, including Adams State, have student populations under 10,000 students. These schools cannot feasibly pay every student-athlete on campus to compete, thereby diminishing opportunities and quickly shattering dreams.

The amateur model the NCAA has upheld in the past has and continues to give underdogs, like myself, a chance. The SCORE Act enables competition at all levels of play, not just for larger schools with the financial resources to compensate athletes. As student-athletes at the Division II level, we support the SCORE Act because it maintains our amateur status and enables us to have the college experience that all students deserve."
